# Is the caregiver...


- \* friendly and in good health?
- \* able to make you feel at ease?
- \* trained to work with children?
- \* able to provide for your child's special needs?
- \* flexible and responsive to the family's needs?

# Will the caregiver...

- **★** read to and talk to your child?
- \* teach your child self-respect and to respect others?
- \* help your child solve problems?
- \* encourage your child to make his or her own choices?
- \* provide a safe environment?
- \* recognize the unique characteristics of each child and plan a program that responds to each child's interests and abilities?

# What services are offered?

- \* Identified specialists through the Program offer consultation, technical assistance, and training to ABC providers, home providers, and providers desiring to serve children with special needs.
- \* Referral for services may be received from child care providers, service providers, early interventionists, and/or parents.
- \* If warranted, funding MAY be available for adapted equipment, removing barriers, or access to services.

# THE ABC SPECIAL NEEDS VOUCHER PROGRAM

### Serves children with:

- \* DISABILITIES (child needs individualized materials, equipment, or instruction)
- DEVELOPMENTAL DELAYS (child demonstrates delay in cognitive, motor, or social development)

by providing vouchers to low income families who need day care services for their children 0 through 18 years.

# Do I qualify?

Parents or guardians must:

- be working (15+ hours per week) or attending an educational or training program (15+ hours per week); and
- agree to share in the cost of day care by paying a weekly copayment.

## *Note* ~

The child must be receiving services through an agency listed in this brochure or through their local school district. If services are through the school district, the parent must contact one of the agencies to receive an application.

# Where can I receive an application?

Applications can be obtained from the child's early interventionist, BabyNet coordinator, service coordinator, or caseworker. The ABC Special Needs Voucher Program does not mail application packets directly to parents or guardians.
