The money set aside in the PASS account can be used towards achieving a reasonable work goal (i.e. pay for transportation, purchase an adapted vehicle, buy supplies for self-employment, etc). The beneficiary will assign their ticket to an Employment Network (EN) or State voc-rehab agency. There is no time limit for using the ticket. The employment agreement can be terminated by the individual OR the Employment Network. A new EN or State voc-rehab agency can be chosen at any time. <p>Through this program, weatherization service providers install energy efficiency measures in the homes of qualifying homeowners free of charge. These are not expensive upgrades—the average expenditure limit is \$2,826 per home—but they are effective, and energy savings pay for the upgrades within a few years. DOE documents the savings and compares them against costs, so that over the years it can determine the efficacy of these measures. Weatherization has helped spawn an energy efficiency industry for residential housing. This industry today employs 8,000 people who work in low-income weatherization alone, and many times that number work in companies that help homeowners increase their energy efficiency through low-cost measures. Many of the techniques that are today standard procedure in this industry were first developed and tested by the Weatherization Program. And through weatherization, DOE continues to develop and test in the field new advances in home energy science. DOE provides funding and technical guidance to the states, but the states run their own programs and set rules for issues such as eligibility. They also select service providers, which are usually nonprofit agencies that serve families in their communities, and review their performance for quality. Together, this group of more than 900 agencies makes up a nationwide weatherization network. IDAs reward the monthly savings of working-poor families who are building towards purchasing an asset - most commonly buying their first home, paying for post-secondary education, or starting a small business. IDAs make it possible for low-income families to build the financial assets they need to achieve the American Dream.	
The match incentive - similar to an employer match for 401(k) contributions - is provided through a variety of government and private sector sources. <p>DHHS administers the Medicaid program for South Carolina; emphasizes Community Long Term Care (CLTC) for home and community based health care for the elderly, people with disabilities, and persons with HIV/AIDS. DHHS administers the Mental Retardation/Related Disabilities (MR/RD) waiver and the Head and Spinal Cord Injured (HASCI) waiver that is operated by the Department of Disabilities and Special Needs (DDSN). DHHS is the lead agency for the ABC Child Care Voucher system, which provides financial assistance to eligible families who need child care. The Bureau of Community Services is a separate program under DHHS that administers the HIV/AIDS waiver, ventilator dependent waiver, elderly/disabled waiver, head/spinal cord waiver, mental retardation/related disabilities waiver; bureau helps to oversee enrollment of providers and nursing homes in conjunction with the state attorney general's office, and other state and federal departments, and investigates complaints of fraud and abuse. DHHS reimburses for various mental health services and providers for those clients having Medicaid coverage. DHHS partners with the Department of Education and provides reimbursement for speech, occupational, and physical therapy offered in the school setting for those students who are Medicaid eligible. DHHS strives to ensure that Medicaid eligible children receive Early Periodic Screening Testing and Diagnosis and well child physician visits. DHHS also offers the South Carolina Services Information System (SCSIS), which is an information and referral system for seniors over 60 and persons with disabilities. <p>Some children with disabilities may receive benefits under the Tax Equity and Fiscal Responsibility Act (TEFRA). TEFRA is an amendment to the South Carolina State Medicaid program. Additionally, all functions related to the Medicaid programs are now housed with the Department of Health and Human Services. If approved for TEFRA / "Katie Beckett" your child will be covered by the same health insurance package that is available to all Medicaid eligible children through other partners for Health programs such as Partners for Healthy Children, or as a benefit for Supplemental Security Income (SSI) recipients.</p>

<p>For people unable to get private health insurance coverage now have the opportunity through the SC Health Insurance Pool. Coverage is available for people who have been state residents for at least thirty days and meet the following criteria: They were turned down for private health insurance coverage for health reason; or they were accepted for private health insurance, but have existing illnesses or conditions excluded from coverage, and have had these conditions for more than 12 months; or they are paying other health insurance premiums that are costlier than the premium levels established when the Pool was created. Other eligibility requirements may also apply. Pool benefits are comparable to many private insurance company plans. The Pool covers a percentage of allowed charges for covered hospital inpatient and outpatient treatment, physician services, certain other medical care and prescription drugs. Persons covered by the Pool pay the remaining percentage and must meet a deductible. Monthly premiums are determined by the person's age and sex. There is no family coverage under the Pool. Each policy is for individual coverage. As administrator, Blue Cross and Blue Shield processes claims, determines eligibility and handles all services required to operate the Pool.</p>

The Urban League also assists with Individual Development Accounts (IDA). IDAs allow an individual to save money for homeownership by matching his/her savings \$2.00 for every \$1.00 up to \$2,000.
